4. CONSIDER AND AGREE THE LOCAL ECONOMIC AND COMMUNITY PLAN

The draft LECP was circulated to Members. This draft incorporates comments/submissions from public consultation. The Advisory Steering Group met to discuss submissions and amendments required to draft LECP. Ms. Siofra Kilcullen advised that there were no substantive changes to the 33 core objectives of the Plan. There are now 177 actions (previously over 200 actions). LGMA had advised that the LECP must include an 'Equality and Human Rights Statement' – refer to Section 2.6.

Councillor Sean MacManus acknowledged work carried out to date on LECP by staff and members of LCDC. Members were asked to focus on targets and indicators and revert with amendments, if any, by 3rd November 2015 with final comments.

The draft Plan will be forwarded to both Municipal Districts and to the Northern and Western Regional Assembly for the adoption of a statement of support. It will then be placed on the Agenda of the January meeting for consideration and adoption by the County Council.

The Committee considered and agreed the draft Plan.

5. UPDATE ON THE PREPARATION OF THE LOCAL DEVELOPMENT STRATEGY (LDS) FOR RURAL DEVELOPMENT PROGRAMME.

LDS circulated to Members 21st October. The LCDC as LAG are to approve the LDS before it is forwarded to the DECLG. It was agreed to establish a RDP Committee in relation to the LEADER Programme, with representatives from the LCDC, Sligo LEADER and Sligo County Council (as Financial Partner).

A number of issues were raised in relation to the draft LDS.

It was suggested that consideration should be given to prioritising in particular the development needs of our rural towns and villages. Due to the impact of the recent recession, many of the rural towns and villages have struggled to survive. Prioritising funding support for the development needs of the hierarchy of towns and villages in the county would be a welcome step in encouraging them to be economic drivers in their own right and to make them more sustainable in the future. This would take time. The Rural Development Programme is an opportunity to make this happen.

Clarification was sought in relation to the role of the Independent Evaluation Committee and the recommendation of proposals for LEADER funding to the LCDC/LAG. There appeared to be a contradiction in relation to this on page 6 section (m) and again on page 11 under the heading of "Screening by the Board of the Sligo LEADER Partnership"

It was confirmed and agreed that it is the Independent Evaluation Committee who will make recommendations for the funding of proposals under LEADER, to the LCDC/LAG, for their final approval. The wording in the LDS is to be deleted and amended to reflect this.
