- **1.** Evidence of Public Liability Insurance Specific Indemnity covering Sligo County Council must be contained within the policy document for no less than €6.4 million.
- 2. Proof of Identity copy of passport/drivers licence to be submitted.
- 3. Copy of Certificate of Motor Insurance.
- 4. Copy of Certificate of Road Worthiness.
- 5. Copy of HSE Food Registration, where selling food (if a new food trader, call HSE on 071-91-85478).
- 6. Pictures of stall/s & waste receptacles.
- 7. Waste Management Plan outlining procedure for 3 receptacle waste segregation system including method of waste disposal & facility where it is disposed.
- 8. Appropriate fee Complete card payment details on this form. See schedule of fees below.

Note: Applicants are advised that the appropriate fee is not taken until the application has been processed & approved. One licence for each location – If trading in more than one area, payment is required for each location.
