#### **GENERAL INFORMATION**

Sligo County Council is the Authority responsible for Local Government in County Sligo. The corporate headquarters are located at County Hall, Riverside, Sligo, and there are three Municipal Districts [Borough District of Sligo (Sligo/Strandhill), Municipal District of Sligo (Sligo/Drumcliffe) and Municipal District of Ballymote-Tubbercurry]. Sligo County Council has 18 elected members and approximately 480 staff. The Chief Executive of Sligo County Council is Mr. Martin Lydon and the Cathaoirleach is Cllr. Dónal Gilroy.

Sligo County Council provides a diverse range of services across a large geographic area. Key services areas include Housing, Planning, Local Enterprise Office, Community and Economic Development, Transportation, Motor Taxation, Environment, Water, Emergency Services along with Libraries and the Arts. These operations are supported by internal services which include ICT, Corporate, Finance and Human Resource functions.

#### **THE COMPETITION**

Sligo County Council is currently inviting applications from suitably qualified persons for the post of Senior Resident Engineer. Sligo County Council will, following an interview process, form a panel for the post from which future relevant vacancies may be filled subject to sanction approval from the Department of Housing, Local Government and Heritage. This panel will exist for one year and may be extended for a further period of one year at the discretion of the Chief Executive. Suitably qualified persons are invited to apply for inclusion on this panel.

#### THE ROLE

The Senior Resident Engineer will be responsible for the on-site supervision of the construction stage of contracts and shall perform the duties allocated. The Senior Resident Engineer's primary role is to ensure that the Contractor carries out all his obligations under the contract. The Senior Resident Engineer shall report to the Director of Services, or any other person designated by the Director of Services in the discharge of their duties.

The post holder will communicate purposefully with the contractor and other stakeholders and monitor the work on site with regard to Health & Safety legislation to ensure that the employers/client's responsibilities are discharged

The Senior Resident Engineer will be responsible for the construction stage of Urban Regeneration and Development Fund (URDF) Public Realm Enhancement projects but may be engaged to work on other Capital infrastructure projects as required during the duration of the contract.

## **QUALIFICATIONS FOR THE POST**

#### 1. Character

Each candidate must be of good character.

## 2. Health

Each candidate shall be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

#### 3. Citizenship

Candidates must, by the date of any job offer, be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who is a spouse or child of an EEA or UK or Swiss citizen and has a stamp 4 visa; or
- (e) A person awarded international protection under the International Protection Act 2015 or any family member entitled to remain in the State as a result of family reunification and has a stamp 4 visa or
- (f) A non-EEA citizen who is a parent of a dependent child who is a citizen of, and resident in, an EEA member state or the UK or Switzerland and has a stamp 4 visa.

#### 4. Education, Training, Experience, etc.

Each candidate shall, on the latest date for receipt of completed application forms:

(a) (i) hold an honours bachelors degree (level 8 on the National Framework of Qualifications (NFQ)) in engineering accredited at CEng or CEng with FL level by Engineers Ireland\*;

(ii) hold an ordinary bachelors degree (level 7 on the National Framework of Qualifications (NFQ)) in engineering **AND** a post-graduate masters degree (level 9 on the National Framework of Qualifications (NFQ)) in engineering;

OR

(iii) hold a masters degree (level 9 on the National Framework of Qualifications (NFQ)) in engineering attained after completing an integrated masters level programme of at least 4 years duration and which is accredited at CEng level by Engineers Ireland or an equivalent accreditation body internationally;

OR

- (iv) have achieved the registered professional title of Chartered Engineer and be registered on the Register of Chartered Engineers of Engineers Ireland or of a professional institute of another country and recognised by Engineers Ireland as of equivalent status;
- (b) have at least **seven (7)** years satisfactory relevant experience of engineering work (preferably to include a minimum of **five (5) years' experience** overseeing capital projects in the capacity of Resident Engineer, including at least three years within complex urban settings);
- (c) possess a high standard of technical training and experience;
- (d) possess a high standard of administrative and management experience;
- (e) have a satisfactory knowledge of public service organisation or the ability to acquire such knowledge.

#### Annex 1 -Criteria for determining equivalence

When determining if a candidate's qualifications can be deemed equivalent to a Level 8 degree in Engineering, the following criteria will be considered:

How has your degree been accredited by Engineers Ireland, or an equivalent accreditation body internationally? Degrees accredited at CEng or CEng with FL level by Engineers Ireland will be understood as a Level 8 Qualification. For International qualifications, consideration will be given to the NARIC Framework and Washington Accord, as appropriate.

Is the degree at Level 8 on the NFQ scale? Where candidates have achieved their degree in other jurisdictions, the level of the qualification will be determined using the NARIC Ireland Foreign Qualification database.

Does the degree contain the level and volume of Engineering modules as would be expected in a Level 8 degree in Engineering? At least 80% of the modules covered in the degree should be focussed on Engineering and the degree should be underpinned by mathematics and the core science subjects.

## **Important Note Regarding Qualifications**

Meeting the educational qualification requirements for the post of Senior Resident Engineer does not automatically mean that your qualifications will meet the requirements for more senior engineering posts within the local authority (e.g. Senior Engineer). More senior grades have separate and higher educational requirements. Candidates should therefore be aware that while the Senior Resident Engineer role provides a pathway into the engineering profession in local government, progression to higher grades will depend on meeting the distinct qualification criteria set for those roles at the time of recruitment.

## 5. <u>Driving Licence</u>

Each candidate must, on the latest date for receipt of completed application forms, hold a full, unendorsed driving licence for Category B vehicles and have access to their own car.

## 6. <u>Desirable Skills/Competencies</u>

The ideal candidate will demonstrate the following:

- Expertise in personnel management with a proven track record of effectively leading multidisciplinary teams to achieve defined strategic objectives;
- Extensive experience engaging with a diverse range of stakeholders in an urban environment—spanning institutional, commercial, political, community, and public domains—to ensure alignment and effective communication throughout project lifecycles;
- Proven capability in leading projects with a strong emphasis on environmental stewardship and sustainable development practices;
- Experience of fulfilling duties required by the Safety Health and Welfare at Work (Construction) Regulations 2013, including ensuring, on behalf of the employer, that the duties of the PSCS, PSDP, Designer and Contractor are implemented across the project;
- Having been responsible for the construction or site supervision of a key infrastructure project in an urban environment, including road and public realm;
- Experience of contract management and an understanding of the authority and responsibility as defined in the contract;

- Hold a valid CSCS ticket in Signing, Lighting and Guarding at Roadworks;
- Experience of the Capital Works Management Framework;
- Experience of Project Management & Cost Management procedures and managing financial resources within a budgetary control framework;
- Detailed knowledge of the Traffic Signs Manual, especially Chapter 8 and experience in dealing with traffic in an urban environment;
- Experience of successfully completing substantial civil engineering contracts, ideally where works were undertaken by a local authority, in an urban environment;
- Excellent interpersonal communication skills and have the ability to liaise with official bodies and members of the media and public in communicating effectively;
- Partnership between, and effective communication with, Client/Consultant/Contractor in progressing a scheme to a successful conclusion;
- Proficiency in AutoCAD, the Microsoft Suite including Microsoft Project and familiarity with ArcGIS.
- Skill in leveraging comprehensive site documentation to substantiate the defence against contractor claims.
- Having contributed to at least one project involving the detailed articulation of claim defences, including the preparation of formal position papers to support negotiations during conciliation proceedings.

Candidates are expected to demonstrate in their application form and at interview that they have the knowledge, understanding, skills and experience required for the role. Candidates will also be assessed under the following key competencies:

## CREATION OF PANEL FOR THE POST OF SENIOR RESIDENT ENGINEER (SPECIFIC PURPOSE CONTRACT – 42 MONTHS DURATION)

#### **PARTICULARS OF OFFICE**

#### 1. THE POST

The post of Senior Resident Engineer is temporary, whole-time and pensionable and will be on a specific purpose contract basis with an expected duration of 3.5 years (42 months).

#### 2. WORKING HOURS

The successful candidate shall be on site as required during all working hours which will include night-time and weekend work based on a 35-hour week. The post holder must reside within reasonable distance of the project site.

#### 3. DUTIES

The duties of the employment are to give to:

- (a) Sligo County Council under the control of the Chief Executive or his nominee and
- (b) To any other local authority or body with which an agreement has been made by the local authority,

Under the general direction and control of the Chief Executive, or of such other employee as the Chief Executive may from time to time determine, such appropriate services of a technical, management, administrative, executive, supervisory, advisory and ancillary nature as may be required by any local authority or body hereinbefore mentioned in the exercise and performance of any of its powers, functions and duties, and to exercise such powers, functions and duties as may be delegated to him or her by the Chief Executive from time to time, including the duty of servicing all committees that may be established by any such local authority or body. The holder of the employment will, if required, act for an employee of a higher level, if qualified to do so.

The duties of the post shall include but are not limited to the following:

- To monitor the construction contract in accordance with the contract documents.
- To be responsible to the Employer's Representative for ensuring that works are carried out in accordance with the Contract Documents.

- To report to the Senior Engineer the Employer's Representative on all matters pertaining to the work on site.
- To ensure that all materials used in the works are in accordance with the specification and that required testing is carried out.
- To monitor compliance with the Safety & Health on site and all Safety and Health Plans.
- To observe and implement all instructions issued by the Senior Engineer Employer's Representative.
- To monitor the progress and performance of the contract.
- To manage and supervise other site supervisory staff as directed by the Line Manager and/or Director of Services.
- To issue instructions to the contractor relating to compliance with the contract requirements.
- To carry out baseline surveys prior to commencement of construction and check contractor's setting-out during construction.
- To keep comprehensive records of work in progress to ensure that events and parameters having contractual implications are properly recorded.
- To review all submissions and proposals submitted by the contractor.
- To record, assess and process any compensation/delay claims submitted by the contractor.
- To report and make recommendations on any claims to the Employer's representative.
- To advise the Employer's Representative in relation to claims and preparation and attendance at any resolution hearings/meetings.
- To prepare valuation of and make recommendation on interim and final payment applications as well as Change Orders.
- To consult and to liaise with Statutory Bodies, landowners, traders, utility companies and the general public as directed by the Senior Executive Engineer, Employer's Representative and/or Director of Services.
- Any other duties which may be assigned from time to time by the Senior Executive Engineer, Employer's Representative and/or the Director of Services.

The Senior Resident Engineer shall be supplied with the following documentation and shall familiarise themselves with the following documents in order to carry out their duties satisfactorily:

- Contract Drawings
- Specification
- Bill of Quantities
- Relevant Conditions of Contract
- o Safety and Health Plan
- Site Investigation Report
- Post Tender Correspondence
- o Relevant Method(s) of Measurement (and any associated handbook).
- Relevant standards and procedures

The duties may include but are not limited to all of the above and the post holder may be required to perform other duties as appropriate to the post which may be assigned to them from time to time and to contribute to the development of the post while in office.

## 4. SALARY

The salary shall be fully inclusive and will be as determined from time to time. Holders of the office shall pay to the local authority any fees or other monies (other than their inclusive salary) payable to or received by them by virtue of their office or in respect of services which they are required by or under any enactment to perform.

The current salary scale for the post is:

€100,754

Salary for the post shall be in accordance with existing practice as set out in relevant circulars. Starting pay for new entrants will be at the minimum of the scale.

## 5. SUPERANNUATION

- a) Persons who become pensionable employees of a local authority who are liable to pay the Class A rate of PRSI contribution will be required, in respect of their superannuation, to contribute to the local authority at the rate of 1.5% of their pensionable remuneration, plus 3.5% of net pensionable remuneration (i.e. pensionable remuneration less twice the annual rate of social insurance old age contributory pension payable at the maximum rate to a person with no adult dependant or qualified children).
- b) Persons who become pensionable employees of a local authority who are liable to pay the Class D rate of PRSI contribution will be required in respect of their superannuation to contribute to the local authority at the rate of 5% of their pensionable remuneration.
- c) All persons under (a) and (b) above who become pensionable employees of a local authority will be required, in respect of the Local Government (Spouses and Children's Contributory Pension) Scheme, to contribute to the local authority at the rate of 1.5% of their pensionable remuneration in accordance with the terms of the Scheme.
- d) Persons who are pensionable under the Single Public Sector Pension Scheme, contributions in respect of Superannuation shall be deducted at a rate of 3% of pensionable remuneration plus 3½% of net pensionable remuneration (i.e. pensionable remuneration less twice the annual rate of social insurance old age contributory pension payable at the maximum rate to a person with no adult dependent or qualified children).

#### 6. PROBATION

There shall be a period after such employment takes effect during which the person appointed will hold the post on probation. Such period shall be six months commencing on the first day of service but the Chief Executive may at their discretion, extend such period. Such person shall cease to hold the post at the end of the period of probation or extended period of probation, unless, during such period or extended period, the service of such person is certified as satisfactory.

#### 7. RETIREMENT AGE

For appointees who are deemed to be "new entrants" as defined in the Public Service Superannuation (Miscellaneous Provisions) Act 2004, there is no compulsory retirement age.

For appointees entering the Single Public Service Scheme, compulsory retirement age will be 70.

For appointees covered under the provisions of the Public Service Superannuation (Age of Retirement) Bill 2018, compulsory retirement age will be 70.

#### 8. RESIDENCE

The holder of the office shall reside in the district in which their duties are to be performed or within a reasonable distance thereof.

#### 9. <u>METHOD OF SELECTION</u>

(a) Selection shall be by means of a competition based on an interview conducted by or on behalf of Sligo County Council. Interviews will be conducted in person. The Council will not be responsible for any expenses incurred by candidates in attending for interview. A panel will be formed of those who are most successful in the competition. The top performing candidates at final selection interview whose names are placed on the panel and who satisfy the local authority that they possess the qualifications declared for the position and that they are otherwise suitable for employment, may within the life of the panel, be employed as appropriate vacancies arise.

The life of the panel shall be one year from the date it is formed, unless extended by the Chief Executive.

## (b) Short-listing

While a candidate may meet the eligibility requirements of the competition, if the numbers applying for the position are such that it would not be practical to interview everyone, Sligo County Council may decide that a smaller amount will be called to the next stage of the selection process. In this respect, the Council provides for the employment of a short-listing process to select a group who, based on an examination of the application forms, appear to be the most suitable for the position. This is not to suggest that other candidates are necessarily unsuitable or incapable of undertaking the job, rather that there are some candidates who, based on their application, appear to be better qualified and/or have more relevant experience.

The short-listing criteria may include both the essential and desirable criteria specified for the position. It is therefore in your own interest to provide a detailed and accurate account of your qualifications/experience in your application.

Candidates may be short-listed for final competitive interview on the basis of:

- the information provided on the application form, including both the essential and desirable criteria, relevant experience and competency questions or
- a preliminary interview or
- a mix of the above.

One or more of the following criteria may apply when short-listing applications either through the application form or preliminary interview:

- Education
- Relevant Work Experience Range & Depth
- Competencies displayed
- Attention to detail

Those deemed most suitable in relation to the relevant criteria will be called for a final competitive interview.

## 10. GARDA VETTING & REFERENCES

The successful candidate may be subject to the Garda Vetting Procedures in line with the provisions of the National Vetting Bureau (Children & Vulnerable Persons) Act 2012 to 2016 as appropriate, in advance of appointment.

The appointment of any successful candidate will be subject to receipt of references which are satisfactory to the employer.

## 11. MEDICAL EXAMINATION

For the purpose of satisfying the requirements as to health, it will be necessary for the successful candidate, before they are appointed, to undergo a medical examination by a qualified medical practitioner to be nominated by the local authority.

## 12. PERIOD OF ACCEPTANCE OF OFFER

The local authority shall require persons to whom appointments are offered to take up such appointments within a period of not more than one month and if they fail to take up the appointments within such period or such longer period as the local authority in its absolute discretion may determine, the local authority shall not appoint them.

#### 13. ANNUAL LEAVE

Annual Leave shall be 30 days per annum. Annual leave and public holidays shall be given in accordance with the provisions of the Organisation of Working Time Act, 1997. The candidate appointed shall be expected to co-ordinate their annual leave with the Contractor's holidays and with other Site Supervisory team members to ensure that adequate site supervision staff are on site at all times during the construction of the works.

#### 14. SICK LEAVE

As per Sligo County Council's current Sick Leave Scheme and Attendance Management Policy & Procedure, as amended by the Public Service Management (Sick Leave) Regulations, 2014, and any subsequent Regulations made from time to time.

## 15. CAR & DRIVING LICENCE

It may be necessary for the person employed to travel in the course of their official duties. The successful candidate shall hold a full driving licence for class B vehicles and shall drive a car in the course of their duties and for this purpose, maintain a car to the satisfaction of the Council.

#### 16. TRAVEL & SUBSISTENCE ARRANGEMENTS

A fixed annual allowance to cover vouched travel and subsistence costs will be paid in respect of day-to-day travel and subsistence arising in the course of the project.

Travel and subsistence expenses, in excess of those expenses covered by the annual allowance, shall be paid in accordance with agreed rates, which may be revised from time to time.

#### 17. LOCATION

The base for working purposes shall be the relevant Site Offices set up by the appointed Contractor for the Project or any other offices as determined by the Local Authority.

## 18. TRAINING

Successful candidates will be required to undertake any course of training which is determined relevant by Sligo County Council.

## 19. <u>DATA PROTECTION</u>
