4. LOCAL ECONOMIC and COMMUNITY PLAN (UPDATE REPORT CIRCULATED)

Presentation from ETB on Actions/Services as related to LECP

Ms. Mary Brodie and Mr. Tom Grady gave a presentation on the services of Mayo Sligo Leitrim Education and Training Board including an update in respect of their actions under 'Education and Training' chapter of the Local Economic and Community Plan.

5. RURAL DEVELOPMENT PROGRAMME (UPDATE REPORT)

Update report circulated to members. Ms. Margaret McConnell advised of the next stage which is contract signing between Sligo County Council, Sligo LCDC and the DECLG. A Service Level Agreement is also to be signed between Sligo County Council, Sligo LCDC and Sligo LEADER Partnership Co.

Mr. Chris Gonley requested that once the contracts have been signed, that a meeting of the LCDC be arranged to discuss the Operating Rules.

6. SOCIAL INCLUSION and COMMUNITY ACTIVATION PROGRAMME

Update report as prepared by Sligo LEADER Partnership Co was circulated to members by Ms. June Murphy. It was noted that the courses provided under Goal 2 of SICAP compliment courses run by the ETB in that they help individuals to build confidence and prepare them to move onto more structured training programmes within ETB.

Mr. Chris Gonley advised that Sligo LEADER Partnership Co work closely with the Department of Social Protection to assist SICAP clients under Goal 3 (Employment). SLPCo intend to link more with employers going forward and identify skills required.

7. PUBLIC PARTICIPATION NETWORK

Update report circulated to members. Ms. Margaret McConnell advised that 2 plenary meetings /Funding workshops have been arranged at Municipal District level, for the 4th May (Ballymote-Tubbercurry MD) and the 10th May (Sligo MD).

It was also noted that the 2016 Work Plan agreed by the Secretariat includes the option of a text alert system for reminding PPN groups of upcoming meetings/events.

Ms. June Murphy (SLPCo) is to circulate agenda for Sligo LEADER Partnership's upcoming workshop with Clan Credo in Collooney on 12th May.

8. PEACE IV PROGRAMME

Report circulated to members.

The members discussed the issue of the most appropriate way for the Council to implement the PEACE plan through the LCDC. Due to the ongoing work load of the LCDC and the cumbersomeness of augmenting the LCDC with members additional to the existing 17 to supplement the gap that exists in the minority faiths, it was agreed that a subcommittee be set up to cover the consideration of the bulk of the operational work involved who would then report and recommend to the LCDC for their discussion and decision.

It was noted that the LCDC would still be responsible for considering and approving the plan in integrated manner in accordance with the recommendation of Special EU Programmes Body (SEUPB) and the Department.
